In the event that the customer will permanently cancel the date of marriage certificate, none of the fees paid will be refunded and the customer is obliged to pay the full amount of the contract entered into as the fees and amounts there is an application for marriage is not refunded from AFL in accordance with the Danish Marriage Act (Ægteskabsloven) § 13, LBK no. 1052 of November 12, 2012, and that the work and services provided to the customer are exclusively to the customer.
- 5. In the event of changes, cancellations, new laws, or modifications to the date of the marriage certificate previously determined by the AFL, the customer is obliged to pay the full amount in accordance with the contract entered between the first party and the customer, considered valid and the customer will not be compensated with any fees
- 6. The first party is considered a mediator who performs all his tasks by receiving documents, coordinating, and checking them, submitting the request, and following it up until the date of marriage certificate is reserved. These services are provided independently, and the fees paid by the customer are not contingent upon the successful issuance of the marriage certificate.
- 7. The period for processing the application is calculated from the date of receipt of copies of the necessary documents and documents in addition to receiving the first payment in our account.
- **8.** The customer undertakes to pay the full fees and provide us with all necessary information and documents in a timely manner.
- 9. In certain circumstances, the date of marriage certificate is booked on a Saturday or Sunday as it requires additional fees such as witnesses and other services (Customer is required to pay).

- 2. No tacit, oral, or written subsidiary agreements have been made beyond those expressly stated in this contract. Changes or additions to this service contract are valid only if agreed upon in writing. This includes amendments to the written clause itself. Any modifications must be documented retroactively for evidentiary purposes.
- 3. This contract has been prepared in two identical copies, one for each party.

Conditions For the Required Documents:

- 1. A passport that is valid for at least 6 months.
- 2. ID or a residence permit that is valid for at least 6 months.
- **3.** If you do not have a residence permit and have a Schengen visa, then the Schengen Visa must be valid for not less than 6 months.
- **4.** The two spouses must not be under 18 years of age.

All documents must be sent to the following email: hazem007@msn.com.

Procedure:

- 1. We send a contract, an invoice and power of attorney to the customer.
- 2. The customer signs the contract and makes the payment.
- **3.** The customer will send a copy of the contract after signing and a copy of the first payment made.
- **4.** The customer will send the necessary documents to submit the application.
- **5.** After completing the documents and submitting the application, we obtain the approval of the marriage within a period of 6 working days, if additional inquiries are required from the Danish register, the processing time may extend beyond 6 working days. The AFL will determine and communicate the estimated timeline for processing and completion.
- **6.** We book a vacancy for a wedding (Marriage certificate) for a period of between two and four weeks.
- **7.** Suitors must visit Denmark in person on the wedding day to complete the marriage certificate process, which typically takes 20 minutes.
- **8.** The couple will receive a copy of the marriage certificate in five languages (Danish, English, German, French and Spanish).
- **9.** The customer (the couple) can get more than one copy of a marriage certificate (not apostille) for free.
